Manifested Harmony Certified Advanced Crystal Healer Code of Ethics and Official Registration Form

The purpose of this form is to ensure that all Manifested Harmony Advanced Crystal Healer's use a safe and ethical crystal healing method as taught by Manifested Harmony.

In order to be certified and practice as a Certified Advanced Crystal Healer, allowing you to use the letters ACH after your name, utilize the ACH logo, and obtain the official certificate of completion, you are required to:

1. Complete *Basic Crystal Healing* and *Advanced Crystal Healing* classes OR *Crystal Healing for Animals* and *Advanced Crystal Healing* from Manifested Harmony.
2. Successfully achieve the status of Certified Crystal Healer or Certified Animal Crystal Healer.
3. Successfully achieve all requirements to become an Advanced Certified Crystal Healer.
4. Agree with the code of ethics set forth here.
5. Fill out the registration form below.

Code of Ethics

1. Practice methods as taught in the courses while also being authentic, intuitive and creative in your work.
2. Continue to work on your own healing and education, and maintaining your own energy balance.
3. Continue your education to enhance your professional qualifications, training, experience and skills in crystal healing. The Crystal Cluster is an easy option.
4. Any information that is discussed during a client session or on intake form is confidential.
5. Never medically diagnose or prescribe. Never suggest that the client/student change medically prescribed treatment or interfere with the treatment of a licensed health care provider. Avoid the use of words such as patient, cure, prognosis, diagnosis, or treat.
6. Provide a safe and comfortable area for sessions or classes and work to provide an empowering and supportive environment for clients and students.
7. Always treat clients and students with the utmost respect and honor.
8. End classes and sessions on time. Be respectful of your client or student's schedule.
9. Engage in active listening with clients and students.

10. Have a pure and clear intention to offer your services for the highest healing good of the client and highest potential of the student.
11. Be respectful of all others' views and paths. Educate, do not debate.
12. Educate clients and students on the value of crystal healing and explain that sessions do not guarantee a cure, nor are they a substitute for qualified medical or professional care. Crystals can be one part of an integrative healing and wellness program.
13. Respect and value other energy workers, even if you disagree with their methods or training.
14. Create your own unique business, session and class materials. Do not plagiarize from other businesses.
15. Empower your clients and students to utilize techniques for self-healing and self-care, assisting them in their personal growth and crystal practices.
16. Always treat your clients and students with the highest respect. Never engage in any illegal or immoral activity with your clients or students. Never touch private bodily areas, never ask them to disrobe, never make sexual comments, jokes or references, never engage in romantic or sexual relations with a client.
17. Do not manipulate the skin unless you are a licensed massage therapist, acupuncturist or ordained and licensed to do so.
18. Abstain from the use of drugs, smoking or alcohol during all professional activities.
19. Avoid the use of harsh chemical cleaners or fragrances in your workspace. Some clients or students may be sensitive so ask ahead of time if essential oil cleaners, diffusers or oils used during sessions or classes would be okay.
20. Practice Truth in Advertising. Be willing to openly discuss your training background, what is offered in a crystal healing session, upfront fee schedule, and the amount of time spent in sessions.
21. Always check your state and local laws to ensure that you comply with all laws and regulations.
22. Obtain liability insurance before working with clients.
23. Engage in education on how to run a successful healing/wellness business and continue your education in best business and online practices for this field of wellness.
